SUPERVISOR BERENS OPENED THE MEETING AND GAVE THE INVOCATION FOLLOWED BY THE PLEDGE OF ALLIGIENCE.

STILLE-MULLIGAN MADE A MOTION TO APPROVE THE SEPTEMBER 2008 MINUTES. HAYWARD SECONDED THE MOTION AND THE MOTION CARRIED.

DISCUSSIONS WERE HELD ON:

1. THE PITTMAN ASPHALT MAINTENANCE BID THAT WAS ACCEPTED ON 10-15-2008. IT WAS REPORTED THAT THE BID DID INCLUDE THE REQUIRED TWO COATS OF SEALER. THE CRACKS WILL BE FILLED IN IMMEDIATELY AND THE BALANCE OF THE WORK WILL BE PERFORMED IN THE SPRING WHEN WEATHER PERMITS.
2. THE RESOLUTION BEING PREPARED FOR JOINT RESPONSIBILITY OF THE RIVER BUOYS IN THE NO-WAKE ZONE FOR ROBINSON AND CROCKERY.
3. ISSUES CONCERNING VARIOUS EXPENDITURES.

STILLE-MULLIGAN MADE A MOTION TO APPROVE THE REQUEST FROM PHIL JOHNSON REPRESENTING THE SOUTH CEDAR MINING SITE TO CLOSE CELL 1 AND HAVE AN INTERIM OPENING OF CELL 6. FRYE SUPPORTED THE MOTION.
