**SUPERVISOR MULLIGAN OPENED THE MEETING. TRUSTEE KUYERS OFFERED AN INVOCATION THAT WAS FOLLOWED BY THE PLEDGE OF ALLEGIANCE.**

BRIGIT LEWIS GAVE A REVIEW OF ASSISTANCE BEING OFFERED BY NOCCA TO SENIORS IN OUR TOWNSHIP. SHE GAVE AN OUTLINE OF HOW THE PROGRAM IS FUNDED. A DISCUSSION WAS HELD BY BOARD MEMBERS ON A POSSIBLE \$1500.00 PAYMENT FROM ROBINSON TOWNSHIP TO HELP WITH THESE SERVICES. REQUIREMENTS FOR PUBLISHING NOTICE AND AGREEMENT WERE REVIEWED WITH RON BULTJE.

BERENS MADE A MOTION TO APPOINT PETE WAMPLER TO THE ROBINSON TOWNSHIP PARK BOARD FOR A THREE YEAR TERM. KUYERS SUPPORTED THE MOTION AND THE MOTION WAS APPROVED.

THE OUTDOOR WOOD FIRED BOILER ORDINANCE WAS REVIEWED. FRYE MADE A MOTION TO TABLE THE APPROVAL OF THE ORDINANCE UNTIL CHANGES COULD BE MADE TO IT CONCERNING EXISTING BOILERS. HAYWARD SUPPORTED THE MOTION AND THE ISSUE WAS TABLED UNTIL THE REGULAR APRIL MEETING

BERENS MADE A MOTION TO APPROVE THE MASTER PLAN CORRECTION RESOLUTION. FRYE SUPPORTED THE MOTION AND THE MOTION CARRIED.

TRUSTEE KUYERS LEFT THE MEETING AT 10:40 A.M.

DISCUSSIONS WERE HELD WITH THE FIRE CHIEF RE: SPENDING LIMITS, BUDGET, AND FIRING AND HIRING POLICIES. RON BULTJE WAS ASKED TO ADD AN AMENDMENT TO THE SPENDING AUTHORITY RESOLUTION TO RAISE THE FIRE DEPARTMENT'S LIMIT TO \$1000.00.

THE PROPOSED BUDGET WAS REVIEWED AND NEEDED BUDGET AMENDMENTS WERE TO BE PREPARED FOR THE ANNUAL MEETING.

AMBULANCE ISSUES AND CITIZEN PLANNER CLASSES WERE DISCUSSED.

FRYE MADE A MOTION TO PAY THE BILLS. HAYWARD SECONDED THE MOTION. THE MOTION CARRIED.

THERE BEING NO FURTHER BUSINESS HAYWARD MADE A MOTION TO ADJOURN. THE MOTION WAS SUPPORTED BY FRYE AND THE MEETING ADJOURNED AT 11:43 A.M.
